



Fixed Income

The Fixed Income module covers instruments traded in the global debt markets. Open-ended design permits virtually any fixed income security to be traded and immediately processed. Features include: real-time inventory of buy/sell and collateral positions; full capabilities for price/yield/discount calculations; and position and counterparty exposure management.

Fixed Income Functions

Transactions

- Buy/sell outright
- When issued
- Repo/reverse all currencies
- Borrow/lend securities

Pricing

- Price/yield calculations supported for all major currencies and all fixed income securities
- New fixed income securities types set up quickly using tables
- Pricing integrated across bond, repo, futures and options markets
- Matrix pricing uses multiple-benchmark curves to price off-the-run issues, corporates, etc.
- Ability to receive online price feed
- Pricing of over-the-counter bond options using links to option on bond futures volatilities

Portfolio Strategies

The portfolio architecture separates strategic centers for performance and management control.

- Investment: long-term positions, accrued at yield-to-maturity, managed with duration
- Mark-to-market: a trading book marked in real time at market prices

- Matched book: a repo/reverse trading book that earns an accrual spread
- Collateral financing: a net long/short position in each issue across all trading desks. Positions at each desk can be automatically flattened at the end of the trading day using dealer-specified rates
- Stress analysis: User-stress scenarios can be run in addition to scenarios based on performance history

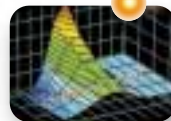
Analytics

- Duration and convexity of portfolio or individual security positions
- Yield-curve sensitivity to multiple-shift scenarios
- Par swaps, bond or bond-future equivalents used for hedging
- Delta and vega risk of options
- Counterparty exposure due to under-collateralised positions

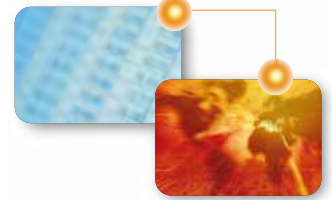
